Government Support for Credit Unions

- DWP and Government believes it is essential that everyone has access to affordable, good-quality financial products and that credit unions have a role in providing this vital service.
- Credit unions and community finance organisations offer a real alternative for people who are unable to access financial products and services through mainstream banks and other financial institutions.
- Between 2006 and 2012, DWP Growth Fund invested £113 million in around 150 credit unions and Community Development Finance Institutions to provide low-income households with affordable credit, as a substitute for the high cost alternatives.
- Government agreed to take forward the findings of the Feasibility Study and announced that DWP will make a further investment in credit unions of up to £38 million up to April 2016.

Credit Union Expansion Project (CUEP)

- The Association of British Credit Unions Limited (ABCUL) was awarded the contract to deliver CUEP through their subsidiary Cornerstone Mutual Services (CMS).
- CUEP commenced in May 2013 and following a contract variation in November 2014 has been extended by 12 months to April 2016.
- ABCUL has contracted with 76 (about 20% of CUs in GB) credit unions to deliver CUEP's
 objectives on growth, sustainability and the provision of improved financial services.
- ABCUL has a time and materials contract contracted with Fiserv, an American company highly regarded for its financial services technology and innovation and with a record of providing services to CU members in USA and to Tesco bank in UK.
- introduced an Automated Lending and Decision System (ALDS) to 71 participating credit unions. Early information is ALD is delivering efficiency savings.
- introduced localised marketing strategies for around 45 CUs that focuses on community based membership growth
